# An Intergovernmental Agreement for

# Structure Replacement Project Section 13-08124-00-BR On TR13 between Coles County & Douglas County

THIS AGREEMENT is entered into between the County of Coles, Illinois and the County of Douglas Illinois on the day of, 2013. The parties hereby state and agree as follows:
---

# A. Purpose and Objectives:

Coles County and Douglas County find it to be in the public's best interest to replace a structure, on TR 13 in Morgan Township.

#### B. Powers:

- 1. The parties are empowered by the Highway Code to provide engineering and construction services to repair or replace existing highway structures. 605 ILCS 5/5-501.
- The parties are empowered by the Intergovernmental Agreement Act (5 ILCS 220/3), and the Illinois Constitution (Ill. Const. 1970, Art. VII, Sec. 10) to enter into this Agreement.
- 3. The Highway Code provides that structures with a waterway opening of 25 square feet or more, located on County Highways or within 80 rods of a county line, shall be constructed and repaired, and the expense of such construction and repair shall be borne in a proportion to the assessed value of the taxable property in the respective counties, according to the last preceding equalized assessment thereof, or on such other just and equitable basis as the parties agree. 605 ILCS 5/5-503.
  - a. Coles County EAV = \$750,957,015
  - b. Douglas County EAV = \$316,156,953

### C. Rights and Responsibilities:

- 1. The cost for the construction and other expenses of said project will be divided accordingly:
  - a. Coles County will contribute 70% of the engineering and construction costs of the project.
  - Douglas County will contribute 30% of the engineering and construction costs of the project.
  - c. Coles County will use their own forces to perform all preliminary and construction engineering duties required for this project.
- The parties hereby agree to take any official action necessary to accomplish their respective obligations, as set forth in this Agreement.

- 3. This writing constitutes the entire agreement of the parties and no other representations related to this Agreement, written or oral, prior to or concurrent with this writing, shall have any effect.
- 4. This Agreement shall be effective as the first date written above.
- This Agreement shall be binding upon and insure to the benefit of the parties hereto, their successors and assignees.
